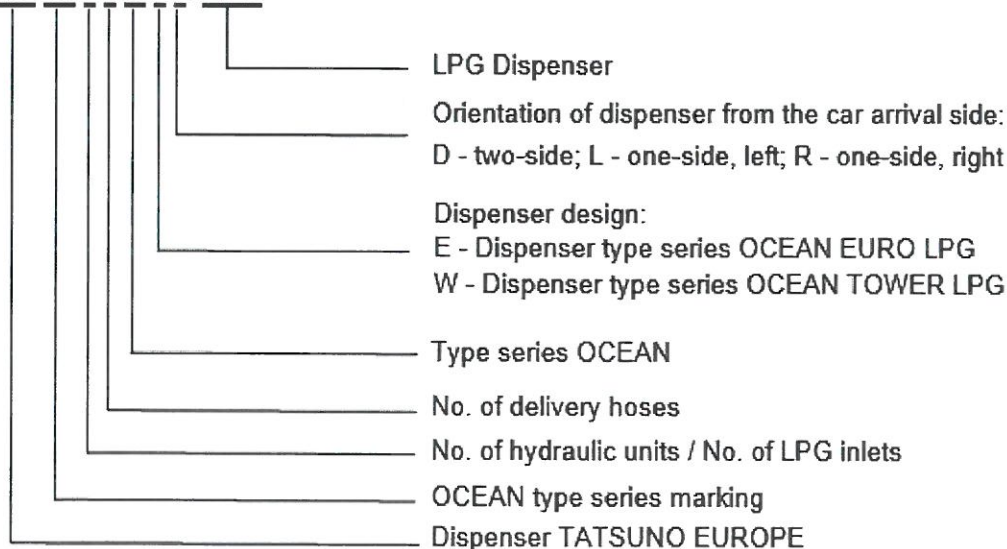
The subject of this supplementary certificate is:





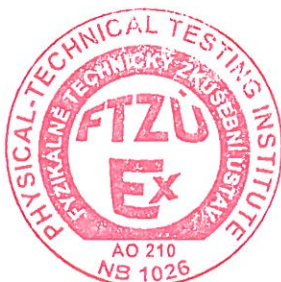
